- Kub bread is closing after 100 years in business.
- Young people do not walk around as much as in the past, basically transportation from one destination to another via bus or car (very little pedestrian), citing

- safety issues, more a "Winnipeg thing" in the downtown and core areas; other major cities in Canada (US etc...) more on top of safety issues.
- Golden Hand moving into new location at 967 Main after several years of delays due to City permit(s) issues. Having more of a "soft opening" with something large planned in the New Year.
- Preference for keeping the board meetings in the afternoons during business hours, not infringing on personal time, keeping to second week of the month, can be Tuesday to Thursday, preference for virtual meetings at this time.
- Recommendation from NEDO that later mid afternoon time slot to allow for Councillor to conclude City obligation(s) schedule, 3:30 or later suggested. Admin to reach out in the next few days to find out what is preferred by Councillor Eadie.
- UNF Hall hosting new Ukrainian immigrants and providing support programs through Main Street location, could be a source of labour for NEB businesses to draw from.
